HEALTH ENHANCEMENT AND LIFESAVING UKRAINE PROJECT (HEAL)





HEALTH SECTOR: DAMAGES, LOSSES AND RECOVERY (RDNA 3)

- The war has caused approximately **US\$1.4 billion in damage** to the health sector infrastructure in Ukraine.
- The total loss was estimated conservatively at U\$\$17.8 billion, including the removal of debris and demolition of the destroyed facilities, loss of income of private providers, losses from the financing of facilities, and additional losses to the population's health due to forgone care and increased public health threats.
- The total recovery and reconstruction needs under the build back better approach are estimated to be **US\$14.2 billion** over 10 years. The **urgent and implementable needs** for 2024 are estimated to be **US\$872.6 million**.
- The GoU and the MoH are moving forward with the rebuilding and recovery of the health sector.
- US\$22 million in damaged / destroyed equipment replaced
- Similarly, strategic health system reforms are moving forward despite the full-scale invasion.

















HEAL UKRAINE: CONTEXT AND SCOPE OF ACTIVITIES

PDO: to restore and improve access to essential mental health and rehabilitation services, address urgent needs for health services, and provide financial protection in emergency context.

Funding: US\$500m approved by the World Bank Board

- **EUR100m** IBRD loan (backed by a Guarantee from the Government of Spain)
- US\$10m grant from GFF for Women, Children and Adolescents
- US\$88m grant from URTF (incl. US\$78m forthcoming in March 2024)
- **EUR100m** CEB loan (forthcoming)



Components:

- MH and rehabilitation services (US\$100m): addressing the new needs of MH and rehab services arising from war-related trauma and the long-term effects of the COVID-19 pandemic (available funding: EUR25m IBRD, US\$50m URTF).
- PHC (US\$150m): reconnecting people to essential PHC services to address the large foregone care burden that has accumulated during the war and pandemic and to improve financial protection form the costs of medicines (available funding EUR57m, US\$8m GFF. US\$28m URTF).
- Hospital care (US\$200m): renovating and equipping hospitals that have been damaged during the war or are otherwise inadequate to meet the needs of the catchment population, aligned with long-term plans for hospital network optimization (available funding EUR10m IBRD, US\$10m URTF).
- Capacity-building, digitalization, and innovations (US\$50m): investment in the eHealth system, strengthening the capacity of the central health agencies, digital support (available funding EUR8m IBRD, US\$2m GFF).



HEAL UKRAINE: IMPLEMENTATION PROGRESS

The HEAL Ukraine project has already disbursed about USD 125 million


- Renovations of primary health care centers
